SECTION 1 - GENERAL INFORMATION

1.0 Background

The City of Clemson, the "City", has always been committed to providing sustainable refuse options for its businesses and citizens. Currently, the City offers a drop off location for glass, plastics, steel, and aluminum. The City collects cardboard and paper on a regular basis. Unfortunately, its recycling options have begun to wane over the last few years as locations willing to accept recyclables have dwindled. One of the collection locations for glass is being shuttered and this will reduce the City's ability to collect glass. The City is actively researching avenues to maintain its glass recycling program.

1.1 Current Operations

The City of Clemson Public Works operates both commercial and residential sanitation programs. Included in sanitation is a recycling program. Plastics, steel, aluminum, and glass are collected at the Public Works facility located at 1155 Old Central Road, Central SC 29630. Paper and cardboard products are collected weekly at both residents and business addresses. In addition to glass being collected at the Public Works facility, it is also collected at Clemson University's "Kite Hill" location. Glass collection at the Kite Hill location will soon cease. Glass collected at both locations are transported to another neighboring government facility for processing. On average there is approximately 2-3 tons of glass collected per month.

1.2 Desired Outcome

The City would like to partner with a vendor that accepts recyclable glass. The City is open to any and all viable options. The City can continue to collect and transport to the recycling facility, provided it is within a reasonable distance from Clemson, SC. Ideally, the City would prefer the vendor transport glass from the Public Works center to the vendors recycling facility. However, we understand that glass recycling should be mutually beneficial for both parties.

1.3 How to Respond

Vendors should respond with their capabilities, current operations, and experience in glass recycling.
