



# Conversation with Council Progress Report as of April 21st, 2023

<b>Action Item</b>	<b>Status</b>
<b>The Berkeley Drive street name sign has been removed at Issaqueena Trail. Can this be replaced?</b> <p>This sign has been replaced.</p>	<b>Complete</b>
<b>Tree roots are damaging Downs Loop near Berkeley Drive. When and how can this be fixed?</b> <p>Tree root uplift of roads caused by mature trees can only be prevented by removing the offending tree and rebuilding the roadway. When Downs Blvd is repaved, the Director of Urban Land Management, Director of Public Works, and City Engineer will work to develop the best method of repair. Downs Blvd is not currently in our three year look ahead paving cycle but will continue to be evaluated.</p>	<b>Ongoing/ Procedure in Place</b>
<b>How can we prevent people heading east on 123 from making U-turns at the College Avenue/133 intersection to head west? Can we add a no U-turn sign or modify the intersection to prevent this from happening?</b> <p>This intersection is controlled by SCDOT. Staff met with SCDOT on April 20th. They are evaluating the condition.</p>	<b>Ongoing</b>
<b>Can the intersection of Hwy 123 and College Ave/133 be made an all stop crossing like the intersection at Douthit Hills?</b> <p>Staff met with SCDOT on April 20th. This request was denied.</p>	<b>Complete</b>
<b>Is Chepstow Whales Clemson's Sister City? Was this ever formalized? If so, we need a sign to acknowledge that.</b> <p>There may have been an informal collaboration, but the City of Clemson has not participated in the Sister City program.</p>	<b>Complete</b>
<b>Do high density housing projects have fire walls between each unit? IBC?</b> <p>Yes. Units are separated with walls that have a one hour fire resistance rating. They also have sprinkler systems.</p>	<b>Procedure in Place</b>
<b>Can a light be installed at the Pendleton Road/Hwy 76 intersection? It is difficult to turn left from hwy 76 onto Pendleton Road because of poor visibility. Can Cats Eyes or reflective paint be used if a light cannot be installed?</b> <p>Staff met with SCDOT on April 20, and they confirmed they are scheduled to restripe this intersection and install reflective raised pavement markers this summer. SCDOT has given permission to pursue the installation of a light, and we are working with Clemson University on a location that will work with their future plans.</p>	<b>In Progress</b>
<b>Can a radar equipped speed limit sign be placed on Issaqueena Trail as you approach Berkeley Drive coming from both directions?</b> <p>SCDOT has approved our request to place signs in these locations as long as they are solar powered. We have ordered 2 driver response speed limit signs and will install them upon arrival.</p>	<b>In Progress</b>
